AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND PURSUANT TO SECTION 9-232 OF THE TAX PROPERTY ARTICLE OF THE ANNOTATED CODE OF MARYLAND TO REPEAL AND REENACT SECTION 144-56(C) AND SECTION 144-57(F) OF ARTICLE XVIII OF CHAPTER 144 OF THE DORCHESTER COUNTY CODE TO PROVIDE THAT RESIDENTIAL PROPERTIES CONSTRUCTED BETWEEN JULY 1, 2019 AND JUNE 30, 2022, AND INCLUDE A COMPLETE AUTOMATIC FIRE PROTECTION SPRINKLER SYSTEM, AND ARE USED AS THE PRINCIPAL RESIDENT OF THE HOMEOWNER, ARE QUALIFIED FOR THE RESIDENTIAL SPRINKLER SYSTEM TAX CREDIT, AND TO PROVIDE THAT THIS ACT SHALL EXPIRE ON JUNE 30, 2023, AND TO PROVIDE THAT THIS ACT SHALL APPLY TO THE REAL PROPERTY TAX BILLINGS AS OF JULY 1, 2019.

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND PURSUANT TO SECTION 9-232 OF THE TAX PROPERTY ARTICLE OF THE ANNOTATED CODE OF MARYLAND TO REPEAL AND REENACT SECTION 144-56(C) AND SECTION 144-57(F) OF ARTICLE XVIII OF CHAPTER 144 OF THE DORCHESTER COUNTY CODE TO PROVIDE THAT RESIDENTIAL PROPERTIES CONSTRUCTED BETWEEN JULY 1, 2019 AND JUNE 30, 2022, AND INCLUDE A COMPLETE AUTOMATIC FIRE PROTECTION SPRINKLER SYSTEM, AND ARE USED AS THE PRINCIPAL RESIDENT OF THE HOMEOWNER, ARE QUALIFIED FOR THE RESIDENTIAL SPRINKLER SYSTEM TAX CREDIT, AND TO PROVIDE THAT THIS ACT SHALL EXPIRE ON JUNE 30, 2023, AND TO PROVIDE THAT THIS ACT SHALL APPLY TO THE REAL PROPERTY TAX BILLINGS AS OF JULY 1, 2019.

SECTION ONE: Acting under Section 9-232 of the Tax Property Article of the Annotated Code of Maryland (the "Act"), be it ENACTED and ORDAINED by the County Council of Dorchester County, Maryland, that Section 144-56(C) and Section 144-57(F) of Article XVIII of Chapter 144 of the Dorchester County Code be repealed and reenacted to read as follows:

Chapter 144

TAXATION

ARTICLE XVIII Residential Sprinkler System Tax Credit

§ 144-56. Definitions.

In this article, the following words have the meanings indicated.

QUALIFIED PROPERTIES – Residential properties that:

- A. Include a complete automatic fire protection sprinkler system; and
- B. Used as the principal residence of the homeowner; and
- C. Constructed between July 1, 2019 and June 30, 2022.

F. This article expires on June 30, 2023.

<u>SECTION TWO:</u> Be it further ENACTED and ORDAINED, by the County Council of Dorchester County, Maryland that General Code Publishers is directed to codify the Amendments to Article XVIII of Chapter 144 in the Dorchester County Code accordingly.

<u>SECTION THREE:</u> Be it further ENACTED, pursuant to Section 308 of the Charter of Dorchester County, Maryland that promptly after enactment of this Act, the County Manager shall cause a fair summary of this Act to be published at least once in a newspaper of general circulation in Dorchester County, Maryland.

SECOND FOUR: Be it further ENACTED and ORDAINED, by the County Council of Dorchester County, Maryland that this Bill shall be known as Bill No. 2019-4 of Dorchester County, Maryland and shall take effect sixty (60) days after its final passage, and shall expire on June 30, 2023. This Act shall apply to the real property tax billings as of July 1, 2019.
