#### County Council of Dorchester County Regular Meeting Minutes January 3, 2023

The County Council of Dorchester County convened in Open Session in Room 110 of the County Office Building at 5:12 p.m. on the 3<sup>rd</sup> day of January, 2023. A roll call of the members was conducted. Present in Room 110 were: George L. Pfeffer, Jr., President; Mike Detmer, Vice President; Rob Kramer, Jr.; William V. Nichols; Ricky C. Travers. Also present in Room 110 was Jeff Powell, Interim County Manager and Donna F. Lane, Executive Assistant to County Manager.

#### **REGULAR SESSION**

INVOCATION AND PLEDGE OF ALLEGIANCE

Councilman Pfeffer led the invocation and the pledge of allegiance.

CALL FOR ADDITIONS OR DELETIONS TO AGENDA

There were no additions or deletions to the agenda.

APPROVAL OF MINUTES

The Council approved the minutes of November 15, 2022 and November 30, 2022.

FINANCIAL REPORT: CASH AND INVESTMENTS

Councilman Pfeffer reported total cash and investments as \$ 33,853,415.51.

#### **CLOSED SESSION SUMMARY**

The Council convened into Regular Session on January 3, 2023 at 5:00 p.m. in Room 110, County Office Building, 501 Court Lane, Cambridge, Maryland 21613 and motioned to adjourn into Closed Session pursuant to Title 3 of the General Provisions Article of the Maryland Annotated Code, pursuant to §3-305(b)(1) to discuss the appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of appointees, employees, or officials over whom it has jurisdiction; and pursuant to §3-305(b)(7) to consult with counsel to obtain legal advice.

- 6- Approved the request of the Director of Emergency Services to hire an individual as a full time Paramedic and individuals as on-call Emergency Medical Technicians by a 5 to 0 vote;

#### MANAGERS COMMENTS

BYRNE JUSTICE ASSISTANCE GRANT AWARD – ANTI-VIOLENCE INITIATIVE – SHERIFF'S OFFICE

The Council, based on the request of James Phillips, Dorchester County Sheriff, accepted the Byrne - Justice Assistance Grant Program, Dorchester County Anti-Violence Initiative grant award of \$43,132 with the performance period of October 1, 2022 to September 30, 2023 and no match requirements. The Council acknowledged that grant will be used to provide funding to the Sheriff's Office for overtime and equipment to support the Dorchester County Anti-Violence Initiative as referenced below:

Personnel:

\$10,000 – Overtime

Equipment:

\$7,632 - Virtual Court Appearance Technology

Other:

\$22,500 - Communications Headset Tactical Team

\$3,000 - Lighting Equipment Tactical Team

REQUEST TO ADVERTISE FOR PROPOSALS – MAPPING SERVICES – ZONING CODE – PLANNING & ZONING

The Council approved the request of Susan Webb, Planning and Zoning Director, to advertise a Request for Proposals for an outside consultant to complete new zoning maps, funded by the current Contractual Service Account FY23 Operating Budget line item. The Council acknowledged that maps must be completed using the geographic information system and be in a digital format.

BID AWARD - RE-APPRAISAL - OBSTRUCTION REMOVAL PHASE 2 - AIRPORT

The Council approved the request of Steve Nuwer, Airport Director, to accept the proposal from W.R. McCain & Associates of \$3,000 to re-appraise the Burns property, Parcel F9, using the Airport's Contractual Services FY23 Operating Budget line item as part of the Airport's Obstruction Removal Phase 2 project. The Council acknowledged that new appraisal is needed for the trial on June 20, 2023 regarding the condemnation for the purpose of avigation easement.

Pursuant to a query from Jeff Powell, Interim County Manager, Mr. Nuwer stated that the avigation easement is for the removal of trees, not to transfer property.

REQUEST TO ADVERTISE FOR PROPOSALS – MOWING COUNTY OWNED PROPERTIES – PUBLIC WORKS

The Council approved the request of Dave Edwards, Public Works Director, to advertise a Request for Proposals for mowing County owned properties as follows; 1) landfill locations; 2) marina and boat ramps for two year contracts and 3) facilities and tax sale properties. The

Council acknowledged that these requests for proposals will be combined into one advertisement.

## REQUEST TO ADVERTISE FOR PROPOSALS – LANDFILL GRINDING RECYCLE SERVICES – PUBLIC WORKS

The Council approved the request of Dave Edwards, Public Works Director, to advertise a Request for Proposals for Landfill Grinding Recycle Services which will be funded by the Landfill Fund Balance. The Council acknowledged that services are required by the Maryland Department of the Environment to remain compliant with the landfill's operating permit.

### TRANSFER TAX & RECORDATION REFUND – CAMBRIDGE WATERFRONT DEVELOPMENT INC. HOLDINGS

The Council approved the request of Matt Leonard, Executive Director, Cambridge Waterfront Development Inc. (CWDI), to refund the recordation and transfer taxes that CWDI paid to acquire the "Hospital Property" consisting of 300 Bryn Street, 400 Bryn Street and 2 Aurora Street as follows:

Recordation Tax: \$10,000 County Transfer Tax: \$7,500

#### LETTER OF SUPPORT REQUEST – TAX EXEMPTION — CWDI HOLDINGS

Based on the request of Mr. Leonard, the Council agreed to provide a Letter of Support to CWDI to accompany their Application for Exemption Governmentally Owned Property for the "Gateway Property" (101 Sunburst Highway and 103 Sunburst Highway) and "Port Property" (Hayward Street) and "Hospital Property."

#### REQUEST TO USE COUNTY GROUNDS & ELECTRIC - CUBMOBILE DERBY

The Council approved the request of Mike O'Connor, Cubmobile Chair, Boy Scouts of America Del-Mar-Va Council, to use the County Office parking lot, grounds and electricity. The Council acknowledged that they will need two sets of bleachers from Recreation & Parks for the Annual Cub Scout Cubmobile Derby on March 19, 2023. The Council acknowledged that 1) Mr. O'Connor contacted the City of Cambridge to request the closure of Court Lane to host the event on Sunday and 2) a Certificate of Liability insurance will be provided prior to the event.

#### BOARD APPOINTMENTS - COINCIDE WITH COUNCIL TERMS

**Ethics Commission** (not by district)

The Council appointed Margaret M. Whitten to the Ethics Commission, as the District 4 representative.

Board of License Commissioners (by district)

Councilmen Travers, Pfeffer, and Detmer said they will serve on the Board of License Commission.

#### **OTHER**

The Council approved the appointment of Michael Larrimore, Sr. to the Police Accountability Board.

In pursuant to Councilman Pfeffer's question, regarding the Board of Appeals (BOA), Susan Webb, Planning and Zoning Director explained that the meetings can only be held when the alternate member is available since there are three vacancies on the board. In response to the vacancies, the Council approved the appointment of Blaine Williamson to the BOA as the District 5 representative.

Mr. Powell stated that he appreciate the Council's trust in him and thanked the staff for their great work ethic, when there is a nationwide employment issue. He recognized Donna Lane, Executive Assistant to County Manager and Duc Trieu, Recreation and Parks Director and thanked the Department Heads for 100% participation during a meeting, noting there is a solid foundation to build on.

#### COUNCIL'S COMMENTS

Councilman Kramer stated he is looking forward to working with Mr. Powell

Councilman Travers reminded everyone of the busy week ahead with the Maryland Association of Counties conference. He said it is going to be a great opportunity to 1) form new relationships;

- 2) meet those at the State level; 3) obtain information on legislation passed or being pursued; and
- 4) take advantage of seminars and trainings.

Councilman Detmer asked Mr. Powell to research the pros and cons of allowing on-call/24 hours staff to use County vehicles, in hopes it will allow staff to respond to an emergency call faster. Councilman Pfeffer added that this may cause tax ramifications to employees.

Councilman Kramer thanked Mr. Edwards for addressing the causeway storm damage in Hoopers Island on such short notice. Councilman Pfeffer added that Ms. Edwards was able to put a team together to reopen the road. In response to Councilman Travers question about accessing the damage, Mr. Edwards explained that the cost of the causeway damages will not meet the \$250,000 threshold of the Maryland Emergency Management Agency or the Federal Emergency Management Agency, noting that damages include guardrails, bulkhead, a washed out road and a temporary patch failing. Mr. Edwards further explained that the guardrail repair started last week, were previously approved and funds were earmarked under the Capital Budget.

Councilman Detmer noted that Griffiths Neck had additional damage during the storm. Mr. Edwards stated the barrels were installed and additional repairs will be made using American Rescue Plan Act funds. Mr. Edwards said the threshold is only for isolated areas and cannot be bundled with other areas.

In response to Councilman Pfeffer regarding a newspaper article, Mr. Edwards said he does not know what the project is, for the setting aside \$100,000 for jetties in Hoopersville.

#### **ADJOURNMENT**

With no further business to discuss, the Council adjourned.
