Councilman Nichols led the invocation and the pledge of allegiance.

CALL FOR ADDITIONS OR DELETIONS TO AGENDA

After publication of the agenda, The Establishment of a Finance Committee was added and the Request to Schedule Public Hearing-Certification of Enterprise Zone-City Of Cambridge-Economic Development was moved from the Consent Agenda to Action Items. The Council approved the amended agenda.

Councilman Pfeffer reported total cash and investments as \$31,805,125.65.

CLOSED SESSION SUMMARY

The Council acknowledged that Ms. Pinder-Hannawald will like to establish March 10th as a day to wear yellow to spread awareness.

MARYLAND VOLUNTARY ORGANIZATIONS ACTIVE IN DISASTER & EASTERN SHORE LONG TERM RECOVERY COMMITTEE

On behalf of the Maryland Voluntary Organizations Active in Disaster (MD VOAD) and Eastern Shore Long Term Recovery Committee (ES LTRC), Reverend Phillip C. Huber, Chair, MD VOAD/ES LTRC, Jennifer Dubosq, Director of Social Services and Kimberly Hopkins, Disaster

Response Coordinator, Boots on the Ground, presented to the Council an overview of their efforts in Dorchester County to assist residents with recovering following the October 29, 2021 tidal flooding that occurred in the Blackwater Reserve area.

CONSENT AGENDA

APPROVAL OF DISBURSEMENTS – WEEK ENDING FERBUARY 17, 2023

The Council approved the vouchers as presented, with Councilman Travers abstaining for payments made to Simmons Center Market.

BUDGET TRANSFER REQUESTS – CORRECTIONS – PUBLIC WORKS

The Council approved the following FY23 Budget Transfer Requests: Department of Corrections; Public Works-Roads; Public Works-Landfill; Public Works-County Office Building and Public Works-County Buildings.

REQUEST FOR AMBULANCE & WAIVER OF FEE – CAMBRIDGE POWERBOAT RACING ASSOCIATION

The Council approved the request of Terry Robbins, Cambridge Powerboat Racing Association, for an ambulance at the race site and to waive the ambulance fee for both the May 20, 2023 to May 21, 2023 and the July 22, 2023 to July 23, 2023 races at Gerry Boyle Park.

REQUEST FOR REFERRAL - SOLAR - PLANNING COMMISSION

The Council approved the request of Susan Webb, Planning and Zoning Director, to refer to the Planning Commission for review and recommendation to the Council the development of solar regulations.

LETTER OF SUPPORT REQUEST-PEOPLE FOR CHANGE COALITION-ECONOMIC DEVELOPMENT

Based on the request of Susan Banks, Economic Development Director, the Council agreed to provide a letter of support to the People for Change Coalition's Early Stage Entrepreneurship Program, that will address barriers faced by socially and economically disadvantaged individuals (SEDI), and non-SEDI on the Eastern Shore.

ACTION ITEMS

TRAFFIC SAFETY COMMITTEE RECOMMENDATIONS - PUBLIC WORKS

The Council approved the recommendation of the Traffic Safety Committee members to extend the 35 mph zone on Elliott Island by 1,500 feet past 2435 Elliott Island Road.

FY23 LOCAL PARKS & PLAYGROUNDS INFRASTRUCTURE PROGRAM-RECREATION AND PARKS

Based on the request of Duc Trieu, Recreation & Parks Director, the Council approved the revision to the FY23 Local Parks & Playground Infrastructure program original request to remove the \$250,000 for renovations of the County's Recreation Center and apply the funds towards the School Street property for development of multi-use fields.

In response to Councilman Nichols' inquiry, Councilman Travers explained that the plan is still in the works and the light style has been changed to address previous concerns about the lights bothering residents. Councilman Pfeffer added that a new parking lot plan has been added to deter people from parking in residents' yards.

REQUEST TO ADVERTISE FOR PROPOSALS – LEGAL SERVICES FOR FAMILY ADVOCACY CLINIC – CIRCUIT COURT

The Council approved the request of Mary O'Donnell, Magistrate, Circuit Court, to advertise a request for proposals to procure the contract services of an attorney or several attorneys, licensed in the State of Maryland, to serve as legal counsel and Director of the new Dorchester County Family Advocacy Clinic which will be funded by the Family Advocacy Grant.

COMMUNITY TRANSPORTATION ADVISORY COMMITTEE APPOINTMENT REQUEST – DELMARVA COMMUNITY SERVICES INC.

The Council deferred the request of Keith Adkins, Deputy Director, Delmarva Community Services, Inc., to appoint members to the Community Transportation Advisory Committee.

BOARD APPOINTMENT & COMPENSATION DISCUSSION – POLICE ACCOUNTABILITY BOARD

The Council acknowledged that it is not an easy process to appoint members to boards and committees and agreed to set the board's compensation at \$100 per meeting.

Councilman Nichols expressed his hope that this board does not have to convene. Councilman Pfeffer noted that the Council needs to elect a Chairperson to the Police Accountability Board and work on appointing members to the Administrative Charging Committee (ACC). The Council agreed to appoint Benny Sampson to the ACC, contingent upon whether or not a Correctional Officer can be appointed.

LETTER OF OPPOSITION-HB692/SB489-PUBLIC SERVICE COMMISSION-CERTIFICATES FOR PUBLIC CONVENIENCE AND NECESSITY-LOCAL PERMITS

The Council agreed to send a letter of opposition for House Bill 692/Senate Bill 489 entitled "Public Service Commission – Certificates of Public Convenience and Necessity – Local Permits" which will eliminate the ability of a local jurisdiction to place any regulation or

restriction on the development of large-scale solar installations, with Councilman Nichols opposing.

POLL CONFIRMATIONS

The Council confirmed its decision in the interim of meetings, via poll, to provide a letter of support for House Bill 1025/Senate Bill 635, Bay Restoration Fund – Authorized Uses – Dorchester County Sanitary District.

REQUEST TO SCHEDULE PUBLIC HEARING-CERTIFICATION OF ENTERPRISE ZONE-CITY OF CAMBRIDGE-ECONOMIC DEVELOPMENT

The Council approved the request of Ms. Banks to schedule a public hearing regarding the redesignation of the City of Cambridge's Enterprise Zone within City limits from the Maryland Department of Business and Economic Development and to start the review process of the resolution. The Council acknowledged that the resolution will be to consent to and apply to recertify the City of Cambridge Enterprise Zone as an Enterprise Zone by the Maryland Department of Commerce.

THE ESTABLISHMENT OF A FINANCE COMMITTEE

The Council approved the request of Mr. Powell to establish a Finance Committee which will be comprised of the Council President, Finance Director and County Manager. The Council agreed that they will meet quarterly and provide updates to the Council.

COUNCIL'S COMMENTS

Councilman Travers apologized for missing the last meeting, as he was under the weather and said it is a pleasure to work with the new council.

Councilman Detmer expressed interest regarding extending the airport runway. After a brief discussion ensued, the Council agreed to submit a letter of interest and request funding simultaneously to potentially start the process of extending the runway.

Pursuant to comments made by Councilman Detmer regarding dredging additional waterways, the Council agreed to have Mr. Edwards and Ms. Lane draft a letter, including Ms. Edwards's recommendations, to request funding from the State to apply to dredging projects. Councilman Detmer stated that he believes that by increasing the waterways it may increase property values, which in turn will increase County revenues.

Councilman Detmer encouraged residents to participate in Senator Chris Van Hollen's proposed Chesapeake National Recreation Area public comment form.

The Council agreed to establish a vacant property registry to increase safety for volunteer firefighters and also potentially increase property values.

Councilman Pfeffer noted to Mr. Edwards that there is trash along Blinkhorn Road and Jackson Street that needs to be removed.

PUBLIC COMMENTS

Joe Dougherty, resident, expressed his concerns regarding the gun range on Ross Neck Road for which he submitted complaints. Ms. Webb explained to Mr. Dougherty that the gun range is not permitted unless a special exception is granted. She noted that a special exception request has been received from the property owner. Mr. Dougherty noted that the local residents that he has spoken to are not in favor of the gun range at that location. The Council acknowledged his concerns.
