The County Council of Dorchester County is requesting proposals for repaving, line stripping, and sidewalk repairs of parking lot in Dorchester County.

Sealed bids, clearly marked "DORCHESTER COUNTY, MARYLAND, DEPARTMENT OF RECREATION AND PARKS PROJECT FOR REPAVING, LINE STRIPPING, AND SIDEWALK REPAIRS FOR PARKING LOT," are to be submitted on October 17th, 2024 at the Dorchester County Office Building, Room 108, 501 Court Lane, Cambridge, MD 21613 no later than 1:00 p.m., at which time bids will be opened in Room 110 of the County Office Building.

**DORCHESTER COUNTY, MARYLAND, DEPARTMENT OF RECREATION AND PARKS PROJECT FOR REPAVING, LINE STRIPPING, AND SIDEWALK REPAIRS FOR PARKING LOT IN CAMBRIDGE, MARYLAND.**

**The Project**

- Dorchester County is accepting proposals from vendors to provide professional repaving, line stripping, and sidewalk repairs for a parking lot. The address of the property is 515 Leonards Lane, Cambridge, MD 21613.

**Scope of Work-Parking Lot**

- Overlay the existing asphalt/concrete parking lot. The parking lot is approximately 14,889 square feet.
- Mill/remove asphalt, as needed, for smooth transitions, tie-ins and to help with maintaining drainage.
- Install a new parking area in the upper left corner of parking lot with asphalt, approximately 320 square feet.
- Removal and re-installation of (34) concrete wheel stops. Replacement of wheel stops
- As needed, apply tack for adhesion purposes.
- Overlay the existing concrete and existing asphalt with 1 ½ " hot mix surface asphalt.
- Roll asphalt for compaction.
- Layout and line stripe the parking lot to match the existing layout.
- Removal of all related debris from premises at the end of each working day.

**Scope of Work-Sidewalk Repairs**

- Replace damaged monolithic curb and sidewalk with wire mesh. The proposed area is 15x5 with a 9x5 and a 5x5 lead walk area.
- Repair three sections of the city sidewalk. The proposed sections are 45x4, 40x4, and 60x4 and has a 20 feet of entry way.
- Repair city curb and gutter. The five sections are 10, 10, 20, 10, and 20 feet respectively. The 20 feet area is in an entry way, nosed and depressed.

**Vendor Qualifications**

- Vendor shall have the wherewithal to provide services as specified, shall have proper insurance, equipment, knowledge, and employees in place to satisfactorily perform the professional installation of a gable roof hardtop pavilion in a timely fashion.

## **Tax Exemption**

- The Department of Recreation and Parks, being a political subdivision, is exempt by law from applicable excise and sales tax.

## **Invoicing**

- Contractor/Company shall provide a W-9 form. Invoices shall be paid approximately within 30 days of receipt. Partial or prepayments must be discussed prior to Invoicing. Final payments will not be made until project is completed to satisfactory.

## **Bidding Form**

- Bids will be submitted on the "Bid Form" that is contained within this document.

## **Reservation**

- The County Council reserves the right to reject any and all bids waive formalities, informalities, and technicalities therein, and to take whichever bid they determine to be in the best interest of the County considering lowest or best bid, quality of goods and work, time of delivery or completion, responsibility of bidders being considered, previous experience of bidders, or any other factors they deem appropriate.

## **Vendor's Insurance**

- The Vendor shall purchase and maintain during the life of this contract, Workman's Compensation Insurance for all of his or any subcontractor's employees employed at the site of the work; and such Public Liability and Property Damage Insurance as shall protect him from claims which may arise from operations under this contract for personal injury (including accidental death) as well as for property damage-whether such operations are by himself or by any subcontractor, or by anyone directly employed by them.

- Public Liability Insurance shall be in the amount not less than \$500,000 for injuries, including wrongful death to any one person; and, subject to the same limit for each person, in an amount not less than \$1,000,000 on account of one accident.
- Property Damage Insurance shall be in an amount not less than \$500,000 for damages on account of any one accident, and in an amount not less than \$1,000,000 for damages on account of all accidents.
- A Certificate of Insurance shall be provided as a condition of a contract award. Dorchester County shall be named as an additional insured.

### **Acceptance and Final Payment**

When in the opinion of the vendor that he has substantially completed the work in a satisfactory manner in accordance with the terms of the contract, the vendor shall submit in writing to the County a request for a determination that the project is complete and suitable for its intended use. The County shall make an inspection of the entire project and shall provide in writing to the Contractor a finding if the project is substantially complete and if so a final punch list of the remaining work to be completed for final completion.

- As a condition for final payment, the vendor shall supply the following:
  - A. Release of Liens-The vendor shall deliver (in a form satisfactory to the County) a written report to the effect that all bills for labor, materials, and supplies have been paid or satisfactorily secured.
  - B. Consent of Surety-Projects bonded by a surety bond will require written Consent of Surety for Final Payment.
