PUBLIC HEARING - SOLAR ENERGY SYSTEMS

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND AMENDING CHAPTER 155 (ZONING) OF THE DORCHESTER COUNTY CODE FOR THE PURPOSES OF REPEALING AND REENACTING § 155-50(LL) TO PROVIDE FOR ACCESSORY, SMALL SCALE, AND UTILITY SCALE SOLAR ENERGY SYSTEMS, ADOPTING REGULATIONS REGARDING THE SAME, DEFINING TERMS ASSOCIATED THEREWITH, AND AMENDING THE TABLE OF PERMITTED USES BY ZONING DISTRICT REGARDING SOLAR ENERGY SYSTEMS; PROVIDING THAT THE TITLE OF THIS BILL SHALL BE DEEMED A FAIR SUMMARY, AND GENERALLY RELATING TO SOLAR ENERGY SYSTEMS IN DORCHESTER COUNTY, MARYLAND.

Ms. Barnes said a public hearing is being conducted on Bill No. 2024-8 to provide for accessory, small scale, and utility scale solar energy systems, adopting regulations regarding the same, defining terms associated therewith, and amending the Table of Permitted Uses by Zoning District regarding solar energy systems; providing that the title of this bill shall be deemed a fair summary, and generally relating to solar energy systems in Dorchester County, Maryland.

Councilman Pfeffer asked for further public comments, hearing none, the public hearing was closed.

Councilman Detmer expressed his concerns relating to solar.

Upon motion by Councilman Detmer, seconded by Councilman Travers, the Council adopted Bill 2024-8 by a 3 to 2 vote, the roll call was: Pfeffer – aye; Detmer – aye; Kramer – nay; Nichols – nay; and, Travers – aye.

Councilman Pfeffer said laws can be amended and modified, if something is not done, we could be facing worse.

The Council adjourned into Open Session.

#### Repaying/Line Stripping

#### LANDFILL HOLIDAY HOURS – HUMAN RESOURCES

Upon motion by Councilman Kramer, seconded by Councilman Detmer, the Council unanimously approved the request of Kristin Budd, Human Resources Director, on behalf of John Cooney, Landfill Manager, Public Works, to update the landfill holiday schedule to allow County landfills and transfer stations to close on all County observed holidays.

## FY25 CAPITAL GRANT AGREEMENT – MARYLAND TRANSIT ADMINISTRATION – DELMARVA COMMUNITY SERVICES

Upon motion by Councilman Travers, seconded by Councilman Kramer, the Council unanimously approved the request of Andrea Waters, Transportation Grants Specialist, Delmarva Community Services, Inc. (DCS) - Delmarva Community Transit, to accept a FY25 Capital Grant Agreement through the Maryland Transit Administration to fund preventative maintenance and the purchase of a small replacement bus, with a project time period of July 1, 2024 to June 30, 2026, and a local match of \$16,315.00 which will be funded by the Non-Profit Fund.

## ACQUISITION OF PROPERTY – GLASGOW TENNIS COURTS – BOARD OF EDUCATION

Upon motion by Councilman Travers, seconded by Councilman Detmer, the Council unanimously approved the request of Duc Trieu, Recreation & Parks Director, to acquire the Glawgow Tennis Courts from the Board of Education (BOE), and install six pickleball courts.

#### COUNTY MANAGER COMMENTS

Mr. Jones reflected on the fatal accident that occurred on Sunday, November 3, 2024 on Route 50 near Austin Road, Cambridge Maryland, and expressed that those in the Public Safety field are heroes. He asked the public to share in this sentiment and check on family members and friends that are in this field.

#### COUNCIL'S COMMENTS

Councilman Nichols recollected an incident across the street from the Elks in Cambridge Maryland, and expressed his appreciation of the Public Safety Division. He said it is an endless, glamourless, and thankless job.

Councilman Travers: 1) said the Glasgow project will be a phased approach, which this is phase one; 2) reiterated Mr. Jones, adding that they implemented Critical Incident Stress Management (CISM) last night and tonight to help the team manage what they saw during the accident, and asked that the public keep them in prayer; and, 3) asked the public to vote on Election Day and pray for our countries healing.

Councilman Detmer: 1) echoed the comments relating to Public Safety and voting; 2) thanked the BOE for its willingness to help us with pickleball; 3) noted the BOE work sessions regarding school renovations and new construction; 4) said November 11, 2024 is Veteranss Day, and that outreach and appreciation is very important.

Councilman Pfeffer: 1) asked the public to please reach out to the BOE regarding meetings as there could be big changes to the school and everyone should get involved; 2) thanked the staff for attending the Council meetings; 3) echoed the comments relating to Public Safety, asked staff to convey the Council's appreciation and to let them know we are here for them.

#### **PUBLIC COMMENTS**

In response to an inquiry from Terry Robbins, resident, Councilman Pfeffer said standards for appropriate notifications of league tournaments will be established by Recreation & Parks.

#### **ADJOURNMENT**

With no further business to discuss, and upon motion by Councilman Kramer seconded by Councilman Detmer the Council unanimously the Council adjourned the meeting at 7:03 p.m.
